FIRST DATA REQUEST OF COMMISSION STAFF TO CHIMNEY ROCK WASTE MANAGEMENT, LLC

Chimney Rock Waste Management, LLC ("Chimney Rock"), pursuant to 807 KAR 5:001, is to file with the Commission the original and eight copies of the following information, with a copy to all parties of record. The information requested herein is due within 14 days of the date of this pleading. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the person who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible. Where information herein has been previously provided, in the format requested herein, reference may be made to the specific location of said information in responding to this information request. When applicable, the information requested herein should be provided for total company operations and jurisdictional operations, separately.

1. Provide a complete listing of all customers currently served by the sewage treatment plant identified as Myrna Burke d/b/a Chimney Rock Campground.

Your response should include service addresses of all customers and all monthly charges assessed to each customer during the calendar year ending December 31, 2000.

2. Provide a balance sheet as of December 31, 2000 and income statement for the year ending December 31, 2000 for the sewage treatment plant identified as Myrna Burke d/b/a Chimney Rock Campground.

3. Who currently owns and operates the campground that will be charged the proposed monthly fee of \$150 per month?

4. Has the ownership of the campground changed within the past 5 years? If so, please provide the names of all parties involved and the roles that they played in the transfer(s).

Do you expect the ownership of the campground to change within the next
5 years? If so, please explain in full detail.

6. How many sewer hook-ups does the campground have? Give a brief description of each hook-up (e.g., public rest room, boat dock, RV clean out).

7. For each sewer hook-up described in response to data request no. 6, provide the following:

a. the number of hookups used for each month in 1999.

b. the number of customers who used the campground for each month in 1999.

c. the charge for the use of each hook-up for every customer in 1999.

8. How was the proposed campground rate determined? Please provide a detailed calculation for each rate charged.

9. How was the residential rate of \$43 determined? Show detailed calculations.

10. Provide a calculation of pro forma annual operating revenues using the proposed rates.

11. Does the sewage treatment facility currently employ a certified operator? If yes, provide a copy of the contract between Chimney Rock and the operator. Also include the operator's name, address and business telephone.

a. If no contract is available, provide the operator's name, monthly salary and description of all duties performed.

b. If Chimney Rock does not employ an operator, please explain the basis for this decision.

12. Provide the operator contract to be in place after the transfer of the sewer operations.

13. Regarding your response to data request no. 12, please provide justification supporting the reasonableness of the proposed certified operator monthly rate.

14. Provide supporting evidence documenting the reasonableness of the following pro forma expenses:
