On July 27, 2001, The Union Light, Heat and Power Company ("ULH&P") filed a motion requesting an extension of time up to and including August 20, 2001, within which to respond to the Commission Staff's 2nd Data Request and the First Request for Information by the Attorney General, both dated July 10, 2001. ULH&P stated that the extension is necessary due to difficulty in retrieving requested information, difficulty in preparing requested analyses and schedules, absence of key personnel, and other business responsibilities. On July 31, 2001, the Attorney General filed a response stating he had no objection to ULH&P's motion.

In its motion, ULH&P acknowledged that the extension would require the modification of the procedural schedule in this case, as established by the Commission's June 21, 2001 and July 13, 2001 Orders. ULH&P suggested that all events be moved by an increment of 3 weeks. In addition, ULH&P stated that if the requested extension of time were granted, it would not implement its proposed rates prior to January 15, 2002.

While the Commission has previously put all parties in this case on notice that it did not look favorably upon motions for continuance, ULH&P has presented compelling reasons for granting its request to delay filing its responses on August 20, 2001. The Commission notes that ULH&P's rates have been suspended up to and including December 5, 2001. ULH&P's statement that it will voluntarily continue this suspension until January 15, 2002 alleviates some of the concerns the Commission has with revising its established procedural schedule. However, because of caseload and other scheduled obligations, the Commission is unable to simply shift the established procedural schedule back 3 weeks, as suggested by ULH&P. A revised procedural schedule is set forth in Appendix A, which is attached hereto and incorporated herein.

IT IS THEREFORE ORDERED that:

1. ULH&P's request to extend the filing date for data requests originally due on July 30, 2001 to August 20, 2001 is granted.

2. The procedural schedule set forth in Appendix A, which is attached hereto and incorporated herein, shall be followed and supersedes the previous schedules established in the Commission's June 21, 2001 and July 13, 2001 Orders.

3. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
