O R D E R

On December 2, 1999, in Case No. 99-312, the Commission approved rates for Millennium Energy, Inc. (Millennium) and provided for their further adjustment in accordance with Millennium s gas cost adjustment (GCA) clause.

On March 29, 2002, Millennium filed its proposed GCA to be effective May 1, 2002.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium s notice includes revised rates to pass on to its customers its expected decrease in gas costs. Millennium s expected gas cost (EGC) is \$5.7263 per Mcf, which is a decrease of .02 cent per Mcf over Millennium s previous EGC of \$5.7265.

2. Millennium s notice sets out no refund adjustment.

3. Millennium s notice sets out an actual adjustment (AA) of (26.55) cents per Mcf to return to customers over-recovered gas costs from November and December 2001 and January 2002. Millennium s total AA is (\$1.0973) per Mcf, which is a decrease of 32.8 cents per Mcf from the previous total AA.

4. Millennium s notice sets out no balance adjustment.

5. Millennium's GCA is \$4.6290 per Mcf, which is 32.82 cents per Mcf less than the previous rate of \$4.9572.

6. The revised rates in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for service rendered by Millennium on and after May 1, 2002.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for service rendered on and after May 1, 2002.

2. Within 20 days of the date of this Order, Millennium shall file with this Commission its revised tariffs setting out the rates authorized herein.
