O R D E R

On February 18, 2003, the Commission issued an Order in this case erroneously listing Doe Valley Association, Inc. as the Applicant. The correct name of the Applicant is Doe Valley Utilities, Inc. (Doe Valley).

Appendix A of that same Order provided that the Commission would schedule a public hearing.

On March 3, 2003, Doe Valley filed a motion for an extension of time to March 10, 2003 in which to respond to the Commission Staff s information request in the Order of February 18, 2003. Good cause having been shown, the Commission finds that the motion should be granted.

IT IS THEREFORE ORDERED that:

1. The style of this case is amended to correctly list Doe Valley Utilities, Inc. as the Applicant in all pleadings herein.
2. The motion of Doe Valley is granted, and the responses to the February 18, 2003 Order are due March 10, 2003.

3. A formal hearing in this matter is scheduled for May 8, 2003, at 9:00 a.m., Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

4. Neither opening statements nor witnesses summaries of prefiled direct testimony will be permitted.

5. Pursuant to 807 KAR 5:001, Section 4(2), Doe Valley shall publish notice of the public hearing, as set out in Appendix A of this Order, no later than April 21, 2003, for two consecutive weeks, prior to the date set for the hearing. Publication shall be in a newspaper of general circulation in the area, pursuant to KRS 424.300, and Doe Valley shall present proof of publication at the hearing.
