## FIRST DATA REQUEST OF COMMISSION STAFF TO UNION LIGHT, HEAT AND POWER COMPANY

The Union Light, Heat and Power Company ( ULH&P ) is requested, pursuant to 807 KAR 5:001, to file with the Commission the original and eight copies of the following information, with a copy to all parties of record. The information requested herein is due no later than 7 days from the date of this information request. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the person who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible. Where information requested herein has been provided, in the format requested herein, reference may be made to the specific location of said information in responding to this information request.

1. Refer to page 3 of the application. Were the construction contractors for the five modules selected by competitive bidding or negotiated contracts? Provide copies of the contracts for the modules and for the service lines for all 2003 projects.

2. Provide the contractual costs for each module, service lines, and for the

work outside of the modules tabulated in Exhibit A of the application.

3. Refer to Paragraph 11 of the Application. Provide the total number of

service lines that ULH&P plans to replace and the total estimated cost for those service

lines for 2003.

4. In 2002, ULH&P replaced approximately 29 miles of cast iron and bare

steel mains. In this proceeding ULH&P is requesting approval to replace approximately

24 miles of cast iron and bare steel mains. This replacement rate appears to exceed

the replacement rate recommended by ULH&P's consultant, Stone & Webster

Consultants, Inc. (Stone & Webster), and the program reviewed and approved by the

Commission in Case No. 2001-00092.<sup>2</sup>
