ORDER

On December 18, 1991, in Case No. 1991-00138, the Commission approved rates for Natural Energy Utility Corporation (Natural Energy), formerly American Natural Gas Corporation, and provided for their further adjustment in accordance with Natural Energy s gas cost adjustment (GCA).

On March 3, 2003, Natural Energy filed its proposed GCA to be effective April 1, 2003.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Natural Energy s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Natural Energy proposed an expected gas cost (EGC) of \$6.4018 per Mcf, which is \$1.5993 per Mcf more than the previous EGC of \$4.8025.
3. Natural Energy s notice sets out no current quarter supplier refund adjustment (RA). Natural Energy s notice sets out no total RA.
4. Natural Energy s notice sets out a current quarter Actual Adjustment (AA) of 17.74 cents per Mcf. Natural Energy s notice sets out a total AA of (51.09) cents per Mcf. Natural Energy incorrectly carried forward the quarterly AAs for two of

the previous quarters. Correcting for this results in a total AA of (52.05) cents, which is 48.76 cents per Mcf more than the previous total AA.

5. Natural Energy's revised GCA is \$5.8813 per Mcf, which is \$2.0869 per Mcf more than the previous GCA of \$3.7944.

6. The rates in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved for service rendered by Natural Energy on and after April 2, 2003. Natural Energy did not give sufficient notice for rates to be effective April 1, 2003.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Natural Energy are denied.
2. The rates in the Appendix, attached hereto and incorporated herein, are approved for service rendered on and after April 2, 2003.
3. Within 20 days of the date of this Order, Natural Energy shall file with the Commission its revised tariffs setting out the rates authorized herein.
