O R D E R

On April 25, 2003, Northeast Woodford County Water District (Northeast Woodford) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.012 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Northeast Woodford purchases water from the city of Versailles (Versailles).

2. Versailles notified Northeast Woodford that effective with its May 1, 2003 billing its wholesale water rates would increase and its rate design would be changed. Northeast Woodford s rate design would change from a five-step declining block design to a customer charge and four-step declining block design. This results in an increased cost in purchased water of \$67,625.48. Northeast Woodford proposes to increase the water rates to its customers effective on the date of this Order.

3. During the 12 months ending December 31, 2002, Northeast Woodford purchased 159,730,000 gallons of water and sold 143,714,000 gallons. The increase in

the cost of purchased water is \$67,625.68, resulting in a purchased water adjustment of \$0.47 per 1000 gallons.

4. The purchased water adjustment of \$0.47 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The proposed rates by Northeast Woodford are accepted.


2. The purchased water adjustment of \$0.47 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after May 31, 2003.

3. Within 20 days of the date of this Order, Northeast Woodford shall file with the Commission revised tariff sheets showing the rates approved herein associated with this transaction.

The following rates and charges are prescribed for the customers in the area served by Northeast Woodford County Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.

5/8 x 3/4" Meter

First	2,000 gallons	\$11.21 Minimum Bill
Next	2,000 gallons	3.93 per 1,000 gallons
Next	6,000 gallons	3.48 per 1,000 gallons
Over	10,000 gallons	2.97 per 1,000 gallons

2-inch Meters

First	20,000 gallons	\$69.65 Minimum Bill
Over	20,000 gallons	2.97 per 1,000 gallons
