O R D E R

On May 10, 2004, the Attorney General, by and through his Office of Rate Intervention ("Attorney General"), moved the Commission to grant an extension of time up to and including May 14, 2004 in which to file his initial data requests, and to amend the procedural schedule accordingly.

The Attorney General states in support of his request that his staff and the experts that he has engaged to assist them in this proceeding have been unavailable to work on this matter due to their involvement in another matter before the Commission. He states that without the requested extension, he will be deprived of meaningful participation in this matter. He further states that counsel for Delta Natural Gas Company, Inc. ("Delta") has agreed to the requested extension provided that the extension will not affect the implementation of rates.

Having considered the motion and being otherwise sufficiently advised, the Commission finds that good cause has been shown to grant the motion and to amend the procedural schedule established by the Commission on April 23, 2004. The Commission further finds that the amended procedural schedule should state the date for the hearing, as well as the date for filing post hearing briefs.

IT IS THEREFORE ORDERED that:

1. The Attorney General's motion is granted.
2. The procedural schedule set forth in Appendix A of the Commission's Order of April 23, 2004 is replaced and superseded by the schedule appended to this Order.
