ORDER

On October 11, 1993, in Case No. 1993-00111, the Commission approved rates for Belfry Gas Company, Inc. ("Belfry") and provided for their further adjustment in accordance with Belfry's gas cost adjustment ("GCA") clause.

On March 8, 2004, Belfry filed its GCA to be effective April 4, 2004.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Belfry's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Belfry's proposed expected gas cost ("EGC") is \$7.3782 per Mcf, which is an increase of \$1.6316 per Mcf from the previous EGC of \$5.7466.
3. Belfry's notice sets out no refund adjustment.
4. Belfry's notice sets out a current quarter actual adjustment ("AA") of .6 cent per Mcf. Belfry's notice sets out a total AA of .42 cent per Mcf, which is an increase of .79 cent from the previous total AA.
5. Belfry's notice sets out no balance adjustment.
6. Belfry's GCA is \$7.3824 per Mcf, which is \$1.6395 per Mcf more than the previous rate of \$5.7429.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Belfry on and after April 7, 2004. Belfry did not provide adequate notice for rates to be effective April 4, 2004.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after April 7, 2004.

2. Within 20 days of the date of this Order, Belfry shall file with this Commission its revised tariffs setting out the rates authorized herein.
