ORDER

Having reviewed the application of Kentucky-American Water Company ("Kentucky-American") and the initial rounds of discovery in this proceeding and finding that the scope and complexity of the issues presented require greater time for review and analysis than originally allowed, and further finding that a public hearing for the purpose of receiving public comment on the proposed rate adjustment should be held, the Commission, on its own motion, HEREBY ORDERS that:

1. The procedural schedule set forth in the Appendix to this Order is substituted for and replaces the procedural schedule set forth in the Appendix to our Order of May 28, 2004.

2. A public hearing for the sole purpose of receiving public comment on the proposed rate adjustment shall be held on November 4, 2004. Kentucky-American shall give notice of this hearing in accordance with Administrative Regulation 807 KAR 5:011, Section 8(5) at such time as the Commission has identified a location and time for such hearing. At the time publication is requested, it shall forward a duplicate of the notice and request to the Commission.

3. At the evidentiary hearing on November 8, 2004, neither opening statements nor surrebuttal testimony shall be allowed. The direct examination of all

witnesses shall be limited to the verification and adoption of previously filed written testimony. No public comment on the proposed adjustment will be taken.

4. All provisions of the Commission's Order of May 28, 2004 that do not conflict with this Order shall remain in full force and effect.
