COMMISSION STAFF'S INTERROGATORIES AND REQUESTS  
FOR PRODUCTION OF DOCUMENTS TO  
SEDALIA WATER DISTRICT

Pursuant to Administrative Regulation 807 KAR 5:001, Commission Staff requests that Sedalia Water District ("Sedalia") shall file with the Commission, within 14 days of the date of this request, the original and 8 copies of the following information, with a copy to all parties of record. Each copy of the data requested should be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the person who is responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible. Where information requested herein has been previously provided, in the format requested herein, reference may be made to the specific location of said information in responding to this information request.

1. State the address of Bob & Ann's Market.
2. State for each month of calendar year 2003 Bob & Ann's Market's usage in gallons and the amount billed to Bob & Ann's Market for water service.
3. Describe how Sedalia customers may currently pay their bills for water service.

4. List each location at which Sedalia customers may currently make payment on their water bills.
5. State the days and hours during which Bob & Ann's Market is currently opened.
6.
  - a. Identify who currently owns Bob & Ann's Market.
  - b. State whether the current owner(s) of Bob & Ann's Market serve on Sedalia's Board of Commissioners or are otherwise employed by Sedalia.
7. Provide the resolution of Sedalia's Board of Commissioners authorizing free water service in exchange for receiving customer payments.
8. Provide the resolution of Sedalia's Board of Commissioners authorizing free water service to each member of the Board of Commissioners.
9. State whether the Graves County Fiscal Court approved the provision of free water service to each member of the Sedalia Board of Commissioners.
10. Describe how Sedalia established the proposed fire sprinkler rate of \$41.16 per month for Vegan Metal. Provide all documents, state all assumptions, and show all calculations used to derive the proposed rate.
11. State the size of the water main that Sedalia uses to provide water service to Vegan Metal.
12. State whether Vegan Metal has a dedicated water line for its fire sprinkler system. If not, describe in detail how Sedalia provides water service to Vegan Metal.
13. Provide all correspondence between Vegan Metal and Sedalia regarding water service to Vegan Metal's fire sprinkler system.

14. Provide all minutes of the meetings of the Sedalia Board of Commissioners in which water service to Vegan Metal's fire sprinkler system is discussed.
