O R D E R

On July 8, 2004, Fulltime Contracting, Inc. ("Fulltime") filed a tariff containing its rates, rules and regulations to operate a natural gas service pursuant to KRS 278.485. The proposed tariff included its Gas Service Contract as well as the following rates for all customers:

Residential/Commercial	\$9.25 per Mcf
Minimum Monthly Charge (Up to 1 Mcf)	\$9.25 per Mcf
Tap Fee	\$150.00
Reconnect Fee	\$25.00
Cash Deposit	\$200.00

Fulltime supplied additional cost information on November 10, 2004 in response to Staff's information request.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that the rates, charges, and terms in the Appendix to this Order are fair, just, and reasonable, in the public interest, and should be approved effective with the date of this Order. The Commission also finds that Fulltime should, pursuant to 807 KAR 5:026, Section 3, provide the Commission with a copy of

all new customer applications and that no service should commence to the new applicants until the Commission has inspected the facilities and determined that all Commission specifications have been met.

IT IS THEREFORE ORDERED that:

1. Fulltime's proposed Residential and Commercial rate, Minimum Monthly Charge, Tap fee, Reconnect Fee and Cash Deposit are approved.
2. Within 30 days of the date of this Order, Fulltime shall file with this Commission its revised tariff showing the effective date, the date of issue, and that it is issued pursuant to this Order.
3. No service shall commence to new customers until the Commission has determined that all Commission specifications have been met.
