### ORDER

On September 10, 2004, Par-Tee LLC d/b/a/ Perry Park Resort ("Par-Tee") filed an application for Commission approval of a proposed increase in sewer rates. Par-Tee proposed to increase its annual revenue from sewer rates by \$11,805, an increase of 35.9 percent over normalized revenue of \$32,888. This proposal would increase the flat rate monthly bill from \$13.33 to \$18.23. Subsequent to the filing of Par-Tee's application, the Commission received a request for intervention from the Attorney General and a letter from Fred Tichenor, a residential customer, protesting the amount of the proposed increase.

By Order dated March 31, 2005, the Commission issued a report that its Staff prepared upon its review of Par-Tee's operations for 2004. In this report Commission Staff recommended that the requested increase be granted. The Commission further directed that any written comments regarding the Staff Report or requests for a hearing or informal conference be filed within 10 days. On April 6, 2005, the Attorney General advised the Commission that he did not request a hearing or an informal conference, nor did he have any objection to submission of this matter for decision based on the current record.

The Commission, having considered the evidence of record and being otherwise

sufficiently advised, finds that:

1. The recommendations and findings contained in the Staff Report are

supported by the evidence of record, are reasonable, and should be adopted as the

findings of the Commission.

2. The rates in Appendix A will produce annual revenue from sewer service

of \$44,977.

IT IS THEREFORE ORDERED that:

1. The findings contained in the Staff Report are adopted and incorporated

by reference into this Order as if fully set out herein.

2. The rates in Appendix A are approved for service rendered by Par-Tee on

and after the date of this Order.

3. Within 30 days of the date of this Order, Par-Tee shall file with the

Commission its revised tariff setting out the rates approved herein.
