O R D E R

Both Louisville Gas and Electric Company (“LG&E”) and Kentucky Utilities Company (“KU”) have filed applications for environmental surcharges to be added to their rates effective later this year. Numerous customers of both utilities have written or called the Commission protesting the rate increases. The Commission finds that a public hearing should be scheduled to allow LG&E’s and KU’s customers to give public testimony on these applications. The Commission further finds that the existing procedural schedule should be revised to include the addition of a public hearing.

IT IS THEREFORE ORDERED that:

1. A public hearing for the purpose of taking public testimony is scheduled in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, at 6:30 p.m., Eastern Daylight Time, on April 20, 2005.
2. The revised procedural schedule, appended hereto, shall be followed in this case.
