On May 24, 2005, the Commission entered an Order in this matter approving the transfer of fuel costs from Louisville Gas and Electric Company's ("LG&E") fuel adjustment clause to its base rates. The rates for Schedule LS - Lighting Service and the rates for LG&E's Special Contracts were inadvertently omitted from Appendix A to the Order. To correct that omission, the rates for Schedule LS and LG&E's Special Contracts are included in Appendix A of this Order.

The Commission THEREFORE ORDERS, nunc pro tunc, that the rates in Appendix A of this Order are the rates to be charged for Schedule LS - Lighting Service and LG&E's Special Contracts, beginning with LG&E's first billing cycle for July 2005.
