O R D E R

Louisville Gas and Electric Company and Kentucky Utilities Company (“LG&E/KU”) have filed a joint application for approval to construct a 750 megawatt super-critical pulverized coal-fired generating unit at their Trimble County Generating Station. To conduct an appropriate review of the application, the Commission finds that the attached procedural schedule should be established. This procedural schedule is subject to modification or supplementation at a later date.

IT IS THEREFORE ORDERED that:

1. The procedural schedule in Appendix A to this Order shall be followed in this proceeding.
2. All requests for information and responses shall be appropriately indexed and 7 copies shall be filed with the Commission, with copies to all parties of record. Any request for information from the Commission Staff shall be responded to as if set forth in

a Commission Order. All responses shall include the name of the witness who will be responsible for responding to questions related to the information provided.

3. Any party filing testimony shall file an original and 10 copies.

4. LG&E/KU shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5). At the time publication is requested, LG&E/KU shall forward a duplicate of the notice and request to the Commission.

5. At any public hearing in this matter, neither opening statements nor summarization of direct testimonies shall be permitted.

6. The Commission may enter further Orders as needed in this matter.
