O R D E R

On May 31, 1996, in Case No. 1994-00433, the Commission approved rates for Bluegrass Gas Sales, Inc. ("Bluegrass") and provided for their further adjustment on a quarterly basis in accordance with Bluegrass's gas cost adjustment ("GCA") clause.¹

On February 23, 2005, Bluegrass filed its proposed GCA to be effective April 1, 2005.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Bluegrass's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Bluegrass's expected gas cost ("EGC") is \$7.9773 per Mcf, which is 67.55 cents per Mcf less than its previous EGC of \$8.6528.
3. Bluegrass's notice sets out no current quarter refund adjustment.

4. Bluegrass's notice sets out a current quarter actual adjustment ("AA") of 9.31 cents per Mcf. Bluegrass's notice sets out a total AA of 65.55 cents per Mcf, which is a decrease of 3.97 cents per Mcf from the previous total AA.

5. Bluegrass's notice sets out a current quarter balance adjustment ("BA") of (1.6) cent per Mcf. Bluegrass's notice sets out a total BA of (3.56) cents per Mcf, which is a decrease of 3.59 cents per Mcf from the previous total BA.

6. Bluegrass's GCA is \$8.5972 per Mcf, which is 75.11 cents per Mcf less than the previous rate of \$9.3483.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Bluegrass on and after April 1, 2005.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after April 1, 2005.

2. Within 20 days of the date of this Order, Bluegrass shall file with this Commission its revised tariffs setting out the rates approved herein.
