O R D E R

On March 14, 2001, in Case No. 2001-00009, the Commission approved rates for Valley Gas, Inc. ("Valley") and provided for their further adjustment on a quarterly basis in accordance with Valley's gas cost adjustment ("GCA") clause.

On March 1, 2005, Valley filed its GCA to be effective April 1, 2005. Valley requested a waiver of the 30-day notice requirement in order for rates to be effective April 1, 2005. The waiver is unnecessary in this case since Valley's notice was received within 30 days of its proposed effective date.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Valley's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Valley's proposed expected gas cost ("EGC") is \$7.4797 per Mcf, which is an increase of \$1.4797 per Mcf from its previous EGC of \$6.00.
3. Valley's notice sets out no current quarter refund adjustment ("RA").
4. Valley's notice sets out a current quarter actual adjustment ("AA") of 41.56 cents per Mcf. Valley's total AA is (84.16) cents per Mcf, which is 41.56 cents per Mcf more than its previous total AA.

5. Valley's notice sets out no Balance Adjustment ("BA"). Valley's notice sets out no total BA, which is no change from its previous total BA.

6. Valley's GCA is \$6.6381 per Mcf, which is \$1.8953 per Mcf more than the previous rate of \$4.7428.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be effective for billing for service rendered by Valley on and after April 1, 2005.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after April 1, 2005.

2. Within 20 days of the date of this Order, Valley shall file with this Commission its revised tariffs setting out the rates authorized herein.
