O R D E R

On March 11, 2005, Elkhorn Water District ("Elkhorn") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Elkhorn purchases water from the city of Frankfort ("Frankfort").
2. Frankfort notified Elkhorn that, effective with consumption used after March 19, 2005, Frankfort's wholesale water rate would increase from \$1.468 per 1,000 gallons to \$1.589 per 1,000 gallons.
3. During the 12 months ending January 2005, Elkhorn purchased 97,181,500 gallons from Frankfort. The increase in the cost of purchased water is \$11,759, resulting in a purchased water adjustment factor of \$0.13 per 1,000 gallons.
4. The purchased water adjustment of \$0.13 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. Elkhorn's proposed rates are approved.

2. The purchased water adjustment of \$0.13 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for water service rendered on and after March 22, 2005.

3. The proposed tariff sheets filed by Elkhorn are accepted as filed.
