COMMISSION STAFF'S DATA REQUEST
TO NAMI RESOURCES COMPANY, LLC

Nami Resources Company, LLC ("Nami") is requested, pursuant to 807 KAR 5:001, to file with the Commission the original and 6 copies of the following information, with a copy to all parties of record. The information requested herein is due within 20 days of the date of this request. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the person who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible. Where information requested herein has been provided, in the format requested herein, reference may be made to the specific location of said information in responding to this information request.

1. Provide the capacity of each well presently operated by Nami and the most recent gas analysis for each well which shows the heat value of the gas stated in Btu per cubic foot.
2. The Gas Price Calculation shown on page 1 of Nami's application includes a 12-month NYMEX strip price of \$7.22. Provide the data that supports this price.
3. Does Nami presently serve 151 customers? Provide the average number of customers served by Nami for each of the years 2002, 2003 and 2004.

4. Nami assumes an average customer uses 90 Mcf annually. For 151 customers, that equates to 13,590 Mcf per year. Provide Nami's total Mcf production for each of the years 2002, 2003 and 2004.

5. Provide Nami's current number of employees.

a. Identify Nami's employees by job title.


b. Provide the average number of persons employed by Nami for each of the calendar years 2003 and 2004.

6. Refer to 807 KAR 5:026, Section 9(b), which is applicable to Nami's situation, i.e. – its proposed percentage increase exceeds the percentage price change in the price index. Section 9(b) states "The [cost] data shall include the gas company's costs to provide the service during each of the previous two (2) years . . ."

a. Explain how the per-unit cost data provided in the "Footnotes" section of Nami's application complies with this requirement.

b. Provide the NYMEX monthly settle price for calendar years 2003 and 2004.

7. Refer to the "Footnotes" section of the application. Provide any employee time records, travel records, etc. which support the estimates of hours worked and travel miles included therein.
