ORDER

On October 22, 2003, in Case No. 2003-00141,¹ the Commission approved rates for Mike Little Gas Company, Inc. ("Mike Little"), and provided for their further adjustment in accordance with Mike Little's gas cost adjustment ("GCA") clause.

On April 1, 2005, Mike Little filed its proposed GCA to be effective May 1, 2005.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Mike Little's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Mike Little's expected gas cost ("EGC") is \$10.5612 per Mcf, which is a decrease of \$1.1733 per Mcf from the previous EGC of \$11.7345.
3. Mike Little's notice sets out no current quarter refund adjustment ("RA"), and it had no RAs from previous quarters.
4. Mike Little's notice sets out a current quarter actual adjustment ("AA") of 59.69 cents per Mcf. Mike Little's notice sets out a total AA of 81.78 cents per Mcf, which is an increase of 46.46 cents per Mcf from the previous total AA.

5. Mike Little's GCA is \$11.3790 per Mcf, which is 70.87 cents per Mcf less than the previous rate of \$12.0877.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Mike Little on and after May 1, 2005.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after May 1, 2005.

2. Within 20 days of the date of this Order, Mike Little shall file with this Commission its revised tariffs setting out the rates authorized herein.
