#### ORDER

On April 10, 1991, in Case Nos. 10288-D and 10288-E, the Commission approved the Gas Cost Adjustment ("GCA") Clause of Auxier Road Gas Company, Inc. ("Auxier") allowing for the quarterly adjustment of its rates.<sup>1</sup>

On May 31, 2005, Auxier filed its proposed GCA to be effective July 1, 2005.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Auxier's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Auxier's Expected Gas Cost ("EGC") is \$8.0451 per Mcf, 38.15 cents per Mcf less than the prior EGC of \$8.4266.
  - 3. Auxier's notice sets out no current refund adjustment.
- 4. Auxier's notice sets out a current quarter actual adjustment ("AA") of (89.57) cents per Mcf. Auxier's notice sets out a total AA of (\$1.0264) per Mcf, a decrease of \$1.2835 cents per Mcf from the previous total AA.

5. Auxier's notice sets out a current quarter balance adjustment ("BA") of .66 cent per Mcf. Auxier's notice sets out a total BA of (1.81) cent per Mcf, which is a decrease of 9.98 cents per Mcf from the previous total BA.

6. Auxier's gas cost recovery rate is \$7.0006 per Mcf, which is \$1.7648 less than the previous rate of \$8.7654 per Mcf.

7. The rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing for service rendered by Auxier on and after July 1, 2005.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after July 1, 2005.

2. Within 20 days of the date of this Order, Auxier shall file with this Commission its revised tariff sheets setting out the rates approved herein.
