ORDER

On March 11, 2005, in Case No. 2005-00032,¹ the Commission approved rates for East Kentucky Utilities, Inc. ("East Kentucky") and provided for their further adjustment on an as needed basis in accordance with East Kentucky's gas cost adjustment ("GCA") clause.

On August 16, 2005, East Kentucky filed its proposed GCA to be effective September 5, 2005. East Kentucky requests a waiver of the 30-day notice period in order to put rates into effect by September 5, 2005. As KRS 278.180 permits the Commission to shorten the required notice period for good cause, the Commission finds the request should be granted.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

East Kentucky's wholesale natural gas contract with Equitable Energy LLC
("EE") provides for an increases in the cost of gas purchased from EE from \$5.50 per
Dth to \$10.80 per Dth, effective August 1, 2005 through October 31, 2005.

2. East Kentucky's notice includes revised rates designed to pass on to its customers its expected increase in wholesale gas costs. Based on the high Btu content of the gas supplied by EE, East Kentucky's expected gas cost is \$14.1555 per Mcf, which represents an increase of \$7.0653 per Mcf above its current gas cost.

3. The rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing with the final meter readings beginning on September 5, 2005.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing with final meter readings by East Kentucky beginning September 5, 2005.

2. Within 20 days of the date of this Order, East Kentucky shall file with this Commission its revised tariffs setting out the rates authorized herein.
