ORDER

On October 11, 1993, in Case No. 1993-00111, the Commission approved rates for Belfry Gas Company, Inc. ("Belfry") and provided for their further adjustment in accordance with Belfry's gas cost adjustment ("GCA") clause.¹

On September 6, 2005, Belfry filed its GCA to be effective October 1, 2005. It subsequently requested a waiver of the 30-day notice period in order to implement its new rate at the beginning of its billing cycle. As KRS 278.180 permits the Commission to shorten the required notice period for good cause, the Commission finds the request should be granted.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Belfry's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Belfry's proposed expected gas cost ("EGC") is \$9.6503 per Mcf, which is an increase of 88.98 cents per Mcf from the previous EGC of \$8.7605.

3. Belfry's notice sets out no current quarter refund adjustment ("RA").

Belfry's notice sets out a total RA of .06 cent which is no change from the prior total RA.

4. Belfry's notice sets out a current quarter actual adjustment ("AA") of (1.98)

cents per Mcf. Belfry's notice sets out a total AA of (11.79) cents per Mcf, which is a

decrease of 6.11 cents from the previous total AA.

5. Belfry's notice sets out no balance adjustment.

6. Belfry's GCA is \$9.5318 per Mcf, which is 82.87 cents per Mcf more than

the previous rate of \$8.7031.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and

should be approved for billing for service rendered by Belfry on and after October 1,

2005.

IT IS THEREFORE ORDERED that:

1. Belfry's request to shorten the period in which it must provide notice of the

proposed adjustment from 30 days to 20 days is granted.

2. The rates in the Appendix, attached hereto and incorporated herein, are

approved for billing for service rendered on and after October 1, 2005.

3. Within 20 days of the date of this Order, Belfry shall file with this

Commission its revised tariff sheets setting out the rates authorized herein.
