<u>ORDER</u>

The Commission has received numerous requests to intervene in this matter from property owners protesting the proposed construction of a telecommunications facility at 900 Kentucky Old Loop #3, Monticello, Wayne County, Kentucky. It appears to the Commission that the property owners ("Petitioners") listed in Appendix A have not requested full intervention, and their property is not contiguous to, or located within 500 feet of, the proposed site; moreover, limited intervention will not unduly delay or disrupt the proceedings or prejudice the rights of the original parties.

IT IS THEREFORE ORDERED that:

1. Each Petitioner listed in Appendix A is granted limited intervention.

2. Each Petitioner shall be entitled to the full rights of a party at any hearing and shall be served with the Commission's Orders, but shall not be served with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties, and shall not be certified as a party for the purpose of receiving service of any petitions for rehearing or petition for judicial review.

3. Should any Petitioner file documents of any kind with the Commission in the course of these proceedings, said Petitioner shall also serve a copy of said documents on all other parties of record.
