O R D E R

On December 16, 2005, the Commission issued an Order approving the request of East Daviess County Water Association, Inc. ("East Daviess") for a Certificate of Public Convenience and Necessity to construct, finance, and increase rates for a \$1,160,000 waterworks improvement project. Appendix A of that Order set out new rates for customers using a 5/8" x 3/4" meter, but it inadvertently omitted new rates for larger-sized meters.

IT IS THEREFORE ORDERED, *nunc pro tunc*, that:

1. The rates set forth in Appendix A are approved for service rendered by East Daviess on and after December 16, 2005.
2. Within 20 days of the date of this Order, East Daviess shall file with the Commission its revised tariff sheets setting forth the approved rates.

3. All provisions of the Commission's Order of December 16, 2005 that are not in conflict with the provisions of this Order remain in full force and effect.

The following rates and charges are prescribed for the customers in the area served by East Daviess County Water Association, Inc. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.

Next 44,000 gallons	3.65 per 1,000 gallons
Over 50,000 gallons	2.95 per 1,000 gallons

3/4" Meter

First 3,000 gallons	\$18.45 Minimum Bill
Next 3,000 gallons	4.60 per 1,000 gallons
Next 44,000 gallons	3.65 per 1,000 gallons
Over 50,000 gallons	2.95 per 1,000 gallons

1" Meter

First 6,000 gallons	\$32.25 Minimum Bill
Next 44,000 gallons	3.65 per 1,000 gallons
Over 50,000 gallons	2.95 per 1,000 gallons

1 1/2" Meter

First 10,000 gallons	\$46.85 Minimum Bill
Next 40,000 gallons	3.65 per 1,000 gallons
Over 50,000 gallons	2.95 per 1,000 gallons

2" Meter

First 20,000 gallons	\$83.35 Minimum Bill
Next 30,000 gallons	3.65 per 1,000 gallons
Over 50,000 gallons	2.95 per 1,000 gallons
