<u>ORDER</u>

On April 29, 2004, in Case No. 2003-00411, the Commission approved rates for Equitable Gas Company, a division of Equitable Resources, Inc. ("Equitable"), and provided for their further adjustment on a quarterly basis in accordance with Equitable's gas cost adjustment ("GCA") clause.¹

On January 3, 2006, Equitable filed its proposed GCA to be effective February 1, 2006.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Equitable's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Equitable's expected gas cost ("EGC") is \$14.4427 per Mcf, which is an increase of 55.06 cents per Mcf from its previous EGC of \$13.8921.

3. Equitable's notice sets out a current quarter actual adjustment ("AA") of 41.34 cents per Mcf. Equitable's total AA is \$1.2325 per Mcf, which is 43.96 cents per Mcf more than the previous total AA.

4. Equitable's notice sets out a current quarter balancing adjustment ("BA") of 1.66 cent per Mcf. Equitable's total BA is 16.06 cents per Mcf, which is 1 cent per Mcf more than the previous total BA.

5. Equitable's GCA is \$15.8358 per Mcf, which is \$1.0002 per Mcf more than its previous rate of \$14.8356.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Equitable on and after February 2, 2006. Equitable did not provide sufficient notice for the rates to be effective February 1, 2006.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order, attached hereto and incorporated herein, are approved for final meter readings on and after February 2, 2006.

2. Within 20 days of the date of this Order, Equitable shall file with this Commission its revised tariffs setting out the rates authorized herein.
