ORDER

On October 22, 2003, in Case No. 2003-00141,<sup>1</sup> the Commission approved rates for Mike Little Gas Company, Inc. ("Mike Little"), and provided for their further adjustment in accordance with Mike Little's gas cost adjustment ("GCA") clause.

On July 3, 2006, Mike Little filed its proposed GCA to be effective August 1, 2006.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Mike Little's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Mike Little's expected gas cost ("EGC") is \$9.505 per Mcf, which is a decrease of \$1.2110 per Mcf from the previous EGC of \$10.7160.
3. Mike Little's notice sets out no current quarter refund adjustment ("RA"), and it had no RAs from previous quarters.
4. Mike Little's notice sets out a current quarter actual adjustment ("AA") of (14.2) cents per Mcf. Mike Little incorrectly calculated its line loss adjustment for

February and March 2006. Correcting for this produces a current quarter AA of (\$1.7339) per Mcf. Mike Little's total AA is \$1.5248 per Mcf, which is an increase of \$1.0750 per Mcf from the previous total AA.

5. Mike Little's GCA is \$11.0298 per Mcf, which is 13.6 cents per Mcf less than the previous rate of \$11.1658.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Mike Little on and after August 1, 2006.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Mike Little are denied.
2. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after August 1, 2006.
3. Within 20 days of the date of this Order, Mike Little shall file with this Commission its revised tariffs setting out the rates authorized herein.
