<u>ORDER</u>

On July 10, 2006, Pendleton County Water District ("Pendleton") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.012 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Pendleton purchases water from the city of Falmouth and Northern Kentucky Water District ("Northern Kentucky").
- 2. Northern Kentucky notified Pendleton that, effective with Northern Kentucky's June 1, 2006 billing, Pendleton's water rate would increase from \$2.40 to \$2.52. Pendleton proposes to increase the water rates to its customers effective June 15, 2006.
- 3. During the 12 months ending June 30, 2006, Pendleton purchased 159,636,300 gallons of water and sold 139,043,740 gallons. The increase in the cost of purchased water is \$12,088.02, resulting in a purchased water adjustment of \$0.09 per 1,000 gallons.
- 4. The purchased water adjustment of \$0.09 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The proposed rates by Pendleton are approved.
- 2. The purchased water adjustment of \$0.09 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after June 15, 2006.
- 3. Within 20 days of the date of this Order, Pendleton shall file with the Commission revised tariff sheets showing the rates approved herein.
