<u>ORDER</u>

On July 18, 2006, Sharpsburg Water District ("Sharpsburg") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Sharpsburg purchases water from Bath County Water District ("Bath County") and the city of Carlisle ("Carlisle").

2. Bath County notified Sharpsburg that, effective with bills rendered after September 1, 2006, Bath County's wholesale water rate to Sharpsburg would increase from \$2.32 per 1,000 gallons to \$2.54 per 1,000 gallons.¹

3. During the 12 months ending June 30, 2006, Sharpsburg purchased 79,745,000 gallons of water from Bath County and 36,586,800 gallons of water from Carlisle and sold 85,828,400 gallons. The increase in the cost of purchased water is \$17,544, resulting in a purchased water adjustment of \$0.20 per 1,000 gallons.

4. The purchased water adjustment of \$0.20 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$0.20 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after August 1, 2006.

2. The proposed tariff sheets filed by Sharpsburg Water District are approved as filed.
