ORDER

On September 27, 2006, the Commission issued a procedural schedule in this matter. It has come to the Commission's attention that certain material appearing on page 3 of that Order needs to be corrected.

The last paragraph on page 3 should now read:

In their July 25, 2001 filing, NANPA, on behalf of the industry, requested that a 19-month schedule for NPA relief be implemented if the Commission adopted an all-services overlay, including 7 months for permissive 7- or 10-digit dialing before mandatory 10-digit dialing begins. A permissive dialing period would be required regardless of which relief method were adopted by the Commission. If a geographic split were adopted by the Commission, a permissive dialing period would be required to allow either the 270 or the new area code to be dialed to a number terminating in the new area code. Customers would continue using 7-digit dialing for local calls within each area code for a geographic split, and calls placed between the two area codes would require 10-digit dialing. Industry members did not recommend an implementation schedule for a geographic split. With either a geographic split or an overlay, all toll calls, whether the calls are to a home NPA or a foreign NPA, would continue to require dialing 1 + 10 digits.

Also, footnote 4 on page 3 should be eliminated.

Moreover, the Commission hereby establishes a schedule for public meetings to present information concerning the 270 NPA relief proposals as submitted by NANPA and to allow public input concerning this matter. The Commission also herein alters the service list to retain as parties all local exchange carriers and wireless providers. Any other provider should notify the Commission of its intent to participate.

IT IS HEREBY ORDERED, to be entered *nunc pro tunc*, that the Commission's September 27, 2006 Order is altered as specified herein.

IT IS FURTHER ORDERED that:

- 1. Public meetings will be held as specified in Appendix A, attached hereto and incorporated herein.
- 2. Within 20 days of the date of this Order, those telephone providers, except local exchange carriers and wireless providers, wishing to participate in this proceeding shall notify the Commission in writing.
