ORDER

On August 3, 2006, Kentucky Power Company ("Kentucky Power") and the Kentucky Association for Community Action, Inc. ("KACA") filed a request for an order approving the programmatic details of the Home Energy Assistance ("EAP") program approved in Kentucky Power's last rate case.¹ The Commission entered an Order on September 21, 2006 directing any party wishing to conduct discovery or request a hearing to notify the Commission within 15 days. On October 5, 2006, the Attorney General moved the Commission for leave to conduct discovery.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that the motion should be granted and that a procedural schedule should be established.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in Appendix A to this Order shall be followed in this proceeding.

2. All interrogatories and requests for production of documents shall be appropriately indexed. Responses shall include the name of the individual responsible for responding to the questions related to the information provided.

3. Service of any document or pleading shall be made in accordance with Administrative Regulation 807 KAR 5:001, Section 3(7), and Kentucky Civil Rule 5.02.

4. All documents that the Commission requires any party to file with the Commission shall also be served upon all parties of record at or before the time of filing.

5. All parties shall respond to any interrogatories and requests for production of documents that Commission Staff submits in accordance with the procedural schedule set forth in Appendix A.

6. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
