O R D E R

On August 28, 2006, East Clark County Water District ("East Clark District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. East Clark District purchases water from the city of Winchester ("Winchester").
2. East Clark District and Winchester through a settlement agreement accepted in Case No. 2005-00322¹ by Order of this Commission on August 16, 2006, revised Winchester's wholesale water rate to \$1.62 per 1,000 gallons.
3. During the 12 months ending June 30, 2006, East Clark District purchased 147,586,384 gallons of water from Winchester and sold 131,300,800 gallons of water. The decrease in the cost of purchased water is \$78,380, resulting in a purchased water adjustment factor of (\$0.60) per 1,000 gallons.

4. The purchased water adjustment of (\$0.60) per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. East Clark District's proposed rates are approved.
2. The purchased water adjustment of (\$0.60) per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for water service rendered on and after August 16, 2006.
3. The proposed tariff sheets filed by East Clark District are accepted as filed.
