O R D E R

On December 8, 2006, North Hopkins Water District ("North Hopkins District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. North Hopkins District purchases water from the city of Madisonville ("Madisonville").
2. Madisonville notified North Hopkins District that, effective January 1, 2007, Madisonville's wholesale water rate to North Hopkins District would increase from \$2.17 per 1,000 gallons to \$2.51 per 1,000 gallons.
3. During the 12 months ending September 30, 2006, North Hopkins District purchased 75,197,000 gallons from Madisonville and sold 66,070,280 gallons. The increase in the cost of purchased water is \$25,567, resulting in a purchased water adjustment factor of \$0.39 per 1,000 gallons.
4. The purchased water adjustment of \$0.39 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. North Hopkins District's proposed rates are approved.
2. The purchased water adjustment of \$0.39 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for water service rendered on and after January 1, 2007.
3. The proposed tariff sheets filed by North Hopkins District are accepted as filed.
