O R D E R

On May 11, 2007, East Daviess County Water Association, Inc. ("East Daviess") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. East Daviess purchases water from the Owensboro Municipal Utilities ("Owensboro").
2. Owensboro notified East Daviess that, effective June 1, 2007, Owensboro's wholesale water rate to East Daviess would increase from \$1.148 per 1,000 gallons to \$1.250 per 1,000 gallons. East Daviess proposes to increase the water rates to its customers effective June 1, 2007.
3. During the 12 months ending May 31, 2006, East Daviess purchased a total of 296,081,010 gallons of water and sold 252,536,902 gallons. The increase in the cost of purchased water is \$30,200, resulting in a purchased water adjustment of \$0.12 per 1,000 gallons.

4. The purchased water adjustment of \$0.12 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The rates proposed by East Daviess are approved.
2. The purchased water adjustment of \$0.12 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after June 1, 2007.
3. Within 20 days of the date of this Order, East Daviess shall file with the Commission revised tariff sheets showing the rates approved herein.
