O R D E R

On May 22, 2007, Cumberland County Water District (“Cumberland Water District”) applied for authority to revise certain non-recurring charges.

Cumberland Water District filed all new revised tariff sheets in addition to the application to revise non-recurring charges. The revised tariff sheets contain Cumberland Water District’s rates, rules, and regulations. In Case No. 2006-00207,<sup>1</sup> we encouraged utilities that have merged or that have revised their tariffs on a piece meal basis over the years to re-file their tariff so as to update the tariff pages while adding necessary or eliminating unnecessary language.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Cumberland Water District has provided adequate cost justification of the individual expenses incurred to provide the services associated with the proposed charges.

2. The proposed charges are equal to the expenses incurred to provide the associated services.

3. The rates and charges set forth in the Appendix to this Order are fair, just and reasonable and should be approved.

4. The rates and charges as contained in the proposed tariff are those as have been previously approved by the Commission or considered in this case.

5. Cumberland Water District's proposed tariff is organized and provides clear language concerning the policies and procedures for the provision of services to the district's customers. The revised tariff should be accepted as filed.

IT IS THEREFORE ORDERED that:

1. The charges in the Appendix are approved for services rendered on and after August 1, 2007.

2. The proposed tariff sheets containing the revised tariff filed by Cumberland Water District are approved as filed.
