COMMISSION STAFF DATA REQUEST

On July 20, 2007, ALLTEL Communications, Inc. ("ALLTEL") filed an application seeking a Certificate of Public Convenience and Necessity ("CPCN") to construct and operate a wireless telecommunications facility to be located at 14305 Old U.S. Route 23, Catlettsburg, Boyd County, Kentucky. The proposed facility consists of a monopole antenna tower not to exceed 189 feet in height, with attached antenna, and the coordinates for the proposed facility are North Latitude 38° 20' 49.95" by West Longitude 82° 36' 9.5".

On July 18, 2007, Cellco Partnership d/b/a Verizon Wireless ("Verizon Wireless") filed an application seeking a CPCN to construct and operate a wireless telecommunications facility to be located at 14305 Old U.S. Route 23, Catlettsburg, Boyd County, Kentucky. The proposed facility consists of a self-supporting antenna tower not to exceed 315 feet in height, with attached antenna, and the coordinates for the proposed facility are North Latitude 38° 20' 45.25" by West Longitude 82° 36' 42.77".

Examination of the coordinates of the two proposed towers, as filed by ALLTEL and Verizon Wireless, indicate that the two sites are separated by approximately one-half mile. The Commission Staff recognizes that there may be an opportunity for both parties to consolidate their facilities on one location. The Commission Staff requests that each carrier provide an analysis of the opportunity to co-locate on a single facility in the area and submit the results of that analysis in writing, to the Commission within 20 days of the date of this request.
