ORDER

On April 10, 1991, in Case Nos. 10288-D and 10288-E, the Commission approved the Gas Cost Adjustment (“GCA”) Clause of Auxier Road Gas Company, Inc. (“Auxier”) allowing for the quarterly adjustment of its rates.<sup>1</sup>

On September 4, 2007, Auxier filed its proposed GCA to be effective October 1, 2007.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Auxier’s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Auxier’s notice sets out an Expected Gas Cost (“EGC”) of \$10.5921 per Mcf, which is an increase of 92.05 cents per Mcf from its prior EGC of \$9.6716.
3. Auxier’s notice sets out no current quarter Refund Adjustment. Auxier’s notice sets out no total RA.

4. Auxier's notice sets out a current quarter Actual Adjustment ("AA") of 8.86 cents per Mcf. Auxier's notice sets out a total AA of (\$2.3761) per Mcf, which is an increase of 29.36 cents per Mcf from its previous total AA.

5. Auxier's notice sets out a current quarter Balance Adjustment ("BA") of (2.5) cents per Mcf. Auxier's notice sets out a total BA of (4.69) cents per Mcf, which is an increase of 4.8 cents per Mcf from its previous total BA.

6. Auxier's Gas Cost Recovery Rate is \$8.1691 per Mcf, which is an increase of \$1.2621 per Mcf from its previous rate of \$6.907.

7. The rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing for service rendered by Auxier on and after October 4, 2007. Since Auxier did not provide sufficient notice for rates to be effective October 1, 2007, the rates will be approved to be effective on and after October 4, 2007.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after October 4, 2007.

2. Within 20 days of the date of this Order, Auxier shall file with the Commission its revised tariff sheets setting out the rates approved herein.
