On May 31, 1996, in Case No. 1994-00433, the Commission approved rates for Bluegrass Gas Sales, Inc. ("Bluegrass") and provided for their further adjustment on a quarterly basis in accordance with Bluegrass's gas cost adjustment ("GCA") clause.¹

On November 26, 2007, Bluegrass filed its proposed GCA to be effective January 1, 2008.

After reviewing the record in this case and being otherwise sufficiently advised,

the Commission finds that:

1. Bluegrass's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Bluegrass's notice sets out an expected gas cost ("EGC") of \$9.5230 per Mcf, which is an increase of \$.7145 per Mcf from its previous EGC of \$8.8085.

3. Bluegrass's notice sets out no current quarter refund adjustment.

4. Bluegrass's notice sets out a current quarter actual adjustment ("AA") of (\$.1183) per Mcf. Bluegrass's total AA is (\$1.1538) per Mcf, which is an increase of \$.0319 per Mcf from its previous total AA.

5. Bluegrass's notice sets out a current quarter balance adjustment ("BA") of \$.0239 per Mcf. Bluegrass's total BA is \$.1587 per Mcf, which is an increase of \$.0134 per Mcf from its previous total BA.

6. Bluegrass's GCA is \$8.5279 per Mcf, which is an increase of \$.7598 per Mcf from its previous rate of \$7.7681.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Bluegrass on and after January 1, 2008.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after January 1, 2008.

2. Within 20 days of the date of this Order, Bluegrass shall file with the Commission its revised tariffs setting out the rates approved herein.
