O R D E R

On January 22, 2008, Burkesville Gas Company, Inc. ("Burkesville") submitted a revised tariff schedule of special service charges. The tariff has an effective date of February 1, 2008. However, Burkesville failed to provide most of the supporting information required for non-recurring charge applications made outside of a general rate case, as required under 807 KAR 5:011, Section 10. Further, in submitting this tariff, Burkesville failed to provide the required 30 days' notice and, therefore, pursuant to KRS 278.180, the tariff could not go into effect. That application has been docketed as Case No. 2008-00123.

On January 24, 2008, Burkesville submitted an application for a general rate increase pursuant to 807 KAR 5:076. That application has been docketed as Case No. 2008-00032. A procedural schedule was issued in that matter on March 25, 2008.

The Commission has reviewed the filings contained in Case No. 2008-00123 and Case No. 2008-00032 and finds the issues of establishment of rates substantially similar in both cases. The Commission further finds that these cases should be consolidated into Case No. 2008-00032 for all administrative purposes. The charges proposed by Burkesville in Case No. 2008-00123 shall be considered for Commission decision concurrently with the rates proposed in Case No. 2008-00032, pursuant to KRS 278.190.

The Commission, being sufficiently advised, HEREBY ORDERS that:


1. Case No. 2008-00032 and Case No. 2008-00123 are consolidated into Case No. 2008-00032 for all administrative and hearing purposes.
2. Burkesville shall have 10 days from the date of this Order to file any objection to the consolidation of these cases.
3. If no objection is filed within 10 days from the date of this Order, Case No. 2008-00123 shall be closed without further Order of the Commission.
4. If, at the expiration of the 10-day period, Burkesville has not objected to the consolidation of these cases, all further filings shall be made in Case No. 2008-00032 and all documents shall contain the following case style:
