ORDER

On May 23, 2008, Kirksville Water Association (“Kirksville Water”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Kirksville Water purchases water from Richmond Utilities (“Richmond Utilities”).
2. On May 23, 2008, Richmond Utilities notified Kirksville Water that, effective July 1, 2008, its wholesale rate to Kirksville Water would increase from \$2.02 per 100 cubic feet of water to \$2.08 per 100 cubic feet.
3. Kirksville Water proposes a purchased water adjustment factor of \$0.10 per 1,000 gallons for its customers, effective July 1, 2008.
4. On June 9, 2008, Kirksville Water sought to amend its Application and include an additional increase from Richmond Utilities as a result of the Kentucky River Authority increasing its withdrawal fee on April 1, 2008. Due to the requirements of 807 KAR 5:068, Section 1, two increases from the same supplier may not be processed

in the same application. The requested amendment will be processed in Case No. 2008-00214.²


5. The purchased water adjustment factor of \$0.10 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. Kirksville Water's proposed rates are approved.
2. The purchased water adjustment factor of \$0.10 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates set forth in Appendix B are fair, just, and reasonable and are approved for service that Kirksville renders on or after July 1, 2008.
4. Within 20 days of the date of this Order, Kirksville Water shall file with the Commission revised tariff sheets setting forth the rates approved herein.
