ORDER

On October 19, 2007, in Case No. 2007-00089,¹ the Commission approved rates for Delta Natural Gas Company, Inc. (“Delta”) and provided for their further adjustment in accordance with Delta’s Gas Cost Adjustment (“GCA”) clause.

On June 26, 2008, Delta filed its proposed GCA to be effective July 28, 2008. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta’s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.

2. Delta’s notice sets out an Expected Gas Cost (“EGC”) of \$15.0146 per Mcf, which is \$3.3260 per Mcf more than the previous EGC of \$11.6886.

3. Delta’s notice sets out no current quarter Refund Adjustment (“RA”). Delta’s notice sets out no total RA, which is no change from the previous total RA.

4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of (\$.6555) per Mcf. Delta's total AA is \$2.3492 per Mcf, which is a decrease of \$.2089 per Mcf from the previous total AA.

5. Delta's notice sets out a Balance Adjustment ("BA") of (\$.1536) per Mcf, which represents a decrease of \$.2050 per Mcf from the previous BA.

6. Delta's GCA is \$17.2102 per Mcf, which is \$2.9121 per Mcf more than the previous GCA of \$14.2981.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after July 28, 2008.


IT IS THEREFORE ORDERED that:

2. Within 20 days of the date of this Order, Delta shall file with this Commission its revised tariffs setting out the rates authorized herein.
