On November 5, 2008, the Commission approved South Logan Water Association's ("South Logan") application for certain nonrecurring charges. Having discovered clerical errors in our Order, the Commission, on our own motion, HEREBY ORDERS, *nunc pro tunc*, that:

1. The second paragraph of the Order of November 5, 2008 is amended to

read as follows:

In its application, South Logan proposed adjustments to increase its returned check charge to \$35. Administrative Regulation 807 KAR 5:006, Section 8(3)(g), permits a utility to assess a charge to recover costs associated with returned checks. The Commission has been guided by KRS 514.040(4)(b) on the reasonableness of a returned check charge. That statute generally limits a merchant's assessment of a "bad check handling fee" to a reasonable amount that does not exceed \$50. South Logan has demonstrated that its actual costs associated with returned checks are \$45.

2. The rates set forth in Appendix A of the Order of November 5, 2008 are

stricken and replaced with the rates that are set forth in Appendix A of this Order.
