ORDER

On August 25, 2008, South Anderson Water District ("South Anderson") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. South Anderson purchases water from the city of Lawrenceburg ("Lawrenceburg") and Frankfort Electric and Water Plant Board ("Frankfort").
- 2. Lawrenceburg notified South Anderson that, effective with its October 1, 2008 billing, the wholesale rate would increase 10 cents (\$0.10) per 1,000 gallons.
- 3. South Anderson proposes a purchased water adjustment factor of \$0.10 per 1,000 gallons.
- 4. During the 12-month period ending June 30, 2008, South Anderson purchased 150,021,000 gallons from Lawrenceburg and 29,220,600 gallons from Frankfort Plant Board and sold 146,748,330 gallons of water during the same time

period. The increase in the cost of purchased water is \$15,002.10, resulting in a purchased water adjustment factor of \$0.10 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.10 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by South Anderson are approved.
- 2. The purchased water adjustment factor of \$0.10 per 1,000 gallons as calculated in Appendix A, which is attached hereto and incorporated herein, is approved.
- 3. The rates in Appendix B, which is attached hereto and incorporated herein, are fair, just, and reasonable and are approved for service provided on or after October 1, 2008.
- 4. Within 20 days of the date of this Order, South Anderson shall file with the Commission revised tariff sheets showing the rates approved herein.
