O R D E R

On October 6, 2008, Ridgelea Investments, Inc. ("Ridgelea") applied for Commission approval to increase its monthly rate for sewer customers from \$22.10 to \$30.00. The proposed increase would generate additional revenues of \$18,865, an increase of 35.75 percent over normalized sewer revenues of \$52,775.

By Order dated October 14, 2008, the Commission issued a Staff Report containing Commission Staff's findings and recommendations regarding the proposed rate adjustment. In its report, Staff recommended that Ridgelea's proposed rates be accepted. In its Order, the Commission directed all parties to file any written comments regarding the Staff Report or requests for a hearing or informal conference within 10 days. If no request for hearing was received within that period, the Commission further ordered, the case would stand submitted for decision. No comments or requests for a hearing or informal conference have been received.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that:

1. The recommendations and findings contained in the Staff Report are supported by the evidence of record, are reasonable, and should be adopted as the findings of the Commission.

2. The rates in Appendix A will produce annual revenue from sewer service of \$71,640.

IT IS THEREFORE ORDERED that:

1. The findings contained in the Staff Report are adopted and incorporated by reference into this Order as if fully set out herein.


2. The rate in Appendix A is approved for service rendered by Ridgelea for its Franklin County operations on and after the date of this Order.

3. Within 30 days of the date of this Order, Ridgelea shall file with the Commission revised tariff sheets setting out the rate approved herein.
