ORDER

On November 20, 2008, Elkhorn Water District ("Elkhorn District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Elkhorn District purchases water from the Frankfort Electric and Water Plant Board ("Frankfort").

2. Frankfort notified Elkhorn District that, due to an increase in water withdrawal fees assessed by the Kentucky River Authority, Frankfort's wholesale water rate to Elkhorn District would increase from \$1.589 per 1,000 gallons to \$1.6355 per 1,000 gallons effective November 30, 2008. Elkhorn District proposes to increase the water rates to its customers effective November 30, 2008.

3. Elkhorn District's application contained a mathematical error in the computation of the proposed rates.

4. During the 12 months ending September 30, 2008, Elkhorn District purchased a total of 63,144,500 gallons of water and sold 59,830,400 gallons. The increase in the cost of purchased water is \$2,936, resulting in a purchased water adjustment of \$0.05 per 1,000 gallons.

5. The purchased water adjustment of \$0.05 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. Elkhorn District's proposed rates are denied.

2. The purchased water adjustment of \$0.05 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after the date of this Order.

3. Within 20 days of the date of this Order, Elkhorn District shall file with the Commission revised tariff sheets showing the rates approved herein.
