ORDER

On December 1, 2008, Cannonsburg Water District ("Cannonsburg") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Cannonsburg purchases water from the City of Ashland ("Ashland") and
 Big Sandy Water District ("Big Sandy").
- 2. Ashland notified Cannonsburg that, effective with its January 1, 2009 billing, Cannonsburg's wholesale water rate would increase from \$1.43 per 1,000 gallons to \$1.89 per 1,000 gallons. Big Sandy notified Cannonsburg that, effective with its December 1, 2008 billing, Cannonsburg's wholesale water rate would increase from \$1.91 per 1,000 gallons to \$1.95 per 1,000 gallons. Cannonsburg proposes to increase the water rates to its customers effective January 1, 2009.
- 3. During the 12 months ending August 31, 2008, Cannonsburg purchased a total of 437,602,380 gallons of water and sold 341,177,500 gallons. The increase in

the cost of purchased water is \$200,010.48, resulting in a purchased water adjustment of \$0.59 per 1,000 gallons.

- 4. While correctly calculating the purchased water adjustment factor that results from the increase in its suppliers' wholesale rates, Cannonsburg incorrectly applied this factor to its current rates. This error produced rates that will recover revenues in excess of the increased expenses due to the increase in purchased water.
- 5. The purchased water adjustment of \$0.59 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. Cannonsburg's proposed rates are denied.
- 2. The purchased water adjustment of \$0.59 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after January 1, 2009.
- 3. Within 20 days of the date of this Order, Cannonsburg shall file with the Commission revised tariff sheets showing the rates approved herein.
