ORDER

On April 10, 1991, in Case Nos. 10288-D and 10288-E, the Commission approved the Gas Cost Adjustment ("GCA") Clause of Auxier Road Gas Company, Inc. ("Auxier") allowing for the quarterly adjustment of its rates.¹

On December 1, 2008, Auxier filed its proposed GCA to be effective January 1, 2009.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Auxier's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Auxier's notice sets out an Expected Gas Cost ("EGC") of \$9.6551 per Mcf, which is a decrease of \$3.0932 per Mcf from its prior EGC of \$12.7483.
3. Auxier's notice sets out no current refund adjustment.
4. Auxier's notice sets out a current quarter actual adjustment ("AA") of (\$.2895) per Mcf. Auxier's total AA is (\$1.7674) per Mcf, which is a decrease of \$.2895 per Mcf from its previous total AA of (\$1.4779).

5. Auxier's notice sets out a current quarter balance adjustment ("BA") of \$.001 per Mcf. Auxier's notice sets out a total BA of (\$.0014) per Mcf, which is a decrease of \$.0012 per Mcf from its previous total BA of (\$.0002).

6. Auxier's gas cost recovery rate is \$7.8863 per Mcf, which is a decrease of \$3.3839 per Mcf from its previous rate of \$11.2702.

7. The rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing for service rendered by Auxier on and after January 1, 2009.

IT IS THEREFORE ORDERED that:


1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after January 1, 2009.

2. Within 20 days of the date of this Order, Auxier shall file with this Commission its revised tariff sheets setting out the rates approved herein.
