O R D E R

On March 2, 2009, the Commission issued an Order in these matters wherein a procedural schedule was set to allow the parties the opportunity to submit a series of replies to Competitive Carriers of the South, Inc.'s ("CompSouth") objection to BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky's ("AT&T Kentucky") Force Majeure declaration. Per that Order, the initial replies are scheduled to be submitted on March 13, 2009.

On March 3, 2009, AT&T Kentucky moved for a one-week extension of time to reply to CompSouth's objection due to the unavailability of its counsel prior to the deadline for the initial replies.

Having reviewed the pleading and the arguments contained therein, the Commission finds that the motion for an extension of time shall be granted. In light of the number of parties to these proceedings and those who may have an interest in the

issue concerned, the Commission finds that the entire schedule should be adjusted to allow a fair amount of time for the submission of replies and sur-replies, including the reply of AT&T Kentucky. The procedural schedule issued on March 2, 2009 shall be amended by this Order and shall be applicable to all parties to these proceedings, including AT&T Kentucky. Upon conclusion of the schedule, the Commission will issue a ruling upon CompSouth's objection.

IT IS THEREFORE ORDERED that:

1. AT&T Kentucky's motion for extension of time is granted.
2. All parties shall abide by the amended procedural schedule set forth in the Appendix attached hereto and incorporated herein, unless otherwise ordered by the Commission.
