O R D E R

On July 3, 2007, Cellco Partnership d/b/a Verizon Wireless ("Verizon Wireless") filed an application with the Commission for a Certificate of Public Convenience and Necessity ("CPCN") to construct a cellular facility near Owingsville, Kentucky. On August 10, 2007, the Commission granted intervention to several adjacent property owners. Verizon Wireless, the Intervenors, and Commission Staff participated in informal conferences on October 24, 2007 and November 28, 2007.

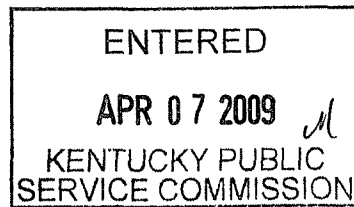
On January 14, 2009, Verizon Wireless filed with the Commission a motion to withdraw its application for a CPCN. As grounds for its motion, Verizon Wireless states that its recent acquisition of Dobson Cellular, which has similar existing facilities in the area, will provide sufficient service coverage in the area to be served by the proposed tower.

The Commission finds that Verizon Wireless has provided good cause that its motion to withdraw the application be granted.


IT IS THEREFORE ORDERED that:
